



# CORPORATE SOCIAL RESPONSIBILITY CHARTER

We behave as socially aware and responsible people, following our company's values, commitments, ethics and rules, centered around the Miyoshi Kasei Group slogan:





Corporate Social Responsibility is treated as a corporate initiative by the Miyoshi Kasei Group, called SDPI (Sustainable Development Performance Initiative). We have endorsed UNGC principles in 2022, as a guidance to help us meet our fundamental responsibilities in our approach to doing business, encompassing human rights, labor practices, environment and anti-corruption. It is implemented and followed up in close cooperation between the head of the Miyoshi Kasei Group and key regional leaders.

The Miyoshi Kasei Group is committed to make all reasonable efforts to communicate the present charter to workers in the group, as well as external partners. As an important stakeholder in the cosmetic ingredients field, the Miyoshi Kasei Group has to present a straight, clear and trustworthy CSR involvement and strategy, addressed to workers, partners and consumers.

Quality is a key cornerstone in driving all our business initiatives. We are committed to deliver products of high quality, which are safe and reliable for users.

The Miyoshi Kasei Group operates in accordance to its quality management program, involving the constant upgrading of our operations and systems in line with Good Manufacturing Practices to sustain high quality and reliability standards.

We constantly survey market needs in order to develop and provide adapted product and service solutions that will fulfill the needs of our customers and the community as a whole.

We continuously invest in our facilities to ensure a safe, ergonomic and quality driven working environment. We do comply with required quality standards in line with product and service concerns.

In the event a problem may occur, we diligently take all necessary steps to investigate all causes, implement corrective actions to prevent reoccurrence and provide detailed information to limit negative consequences.

# 2 Treating people right

# 2.1 Labor practices



We truly believe the success and future development of our company relies on the involvement, commitment and enthusiasm of our talented people.

We do value and promote team work, self-initiative, individual respect, sharing of knowledge and value creation, in an amicable working environment.

The Miyoshi Kasei Group respects the basic rights of its employees regarding freedom of association and collective bargaining. The company complies with all local laws governing the right of employees to select or not select workplace representatives.

#### 2.1.1 Career management and Training

The Miyoshi Kasei Group commits to respect the values and skills of each employee and treats all of them with fairness regarding their abilities, responsibilities and performance.

We recognize the growth potential of our employees and enable them to develop and practice their talents and skills. We implement employee training programs to pro-actively address any concern and ameliorate the work practices.

#### 2.1.2 Wages

The Miyoshi Kasei Group is committed to comply with all applicable wage and hour regulations, including those relating to minimum wages, overtime hours and other elements of compensation. Employees are paid regularly, on time and with fairness in respect of work performance.

#### 2.1.3 Human rights, equality and diversity

The Miyoshi Kasei Group does not discriminate against its employees in hiring, remuneration, promotion or termination practices. It includes discrimination based on, but not limited to: race, religion, color, national origin, gender, sexual orientation, disability, age, ethnic origin, social status, or political opinion.

The Miyoshi Kasei Group workers must not engage in any kind of physical, verbal, psychological or sexual abuse or misconduct.

#### 2.1.4 Forced and child labor

Labor practices are looked upon very seriously, and the Miyoshi Kasei Group engage in not employing children under the legal working age of the country or region concerned, or forced labor of any kind. Furthermore, workers must be allowed to leave their employment after giving reasonable notice.

# 2.2 Health and safety

#### 2.2.1 Workers



The Miyoshi Kasei Group core values involve providing a safe and healthy working environment for every employee. It includes assessing and managing risks, minimizing unsafe conditions and encouraging a safety culture and conscious behavior:

- We are committed to implement all possible solutions that will ensure the safety of each employee.
- We do comply with all relevant laws and regulations related to health and safety conditions in the workplace.
- We do maintain and enhance the work environment to favor safe and healthy conditions for everyone.
- We do our best to prevent incidents and accidents and implement internal systems including employee training programs to address any concern and optimize the work environment.

#### 2.2.2 Consumers

The Miyoshi Kasei Group is committed to provide products and services that offer peace of mind and safety to consumers. It involves providing ample disclosure of information and building healthy and trustworthy communication. Legal texts or consumers related concerns are duly monitored and actions are organized when needed, to ensure compliance and full information for consumers.

#### 2.3 Social network

The Miyoshi Kasei Group considers its social environment, in addition to economic and environmental factors, while conducting business. The interactions with partners, governments, professional associations, territorial agencies and other stakeholders, are cultivated to facilitate long-term and beneficial relationships, as it strives to realize a sustainable society.

# 3 Treating stakeholders right

#### 3.1 Business ethic

We view all our suppliers and customers as partners working together with us toward sustained growth and who have values that are directed to conducting business in full compliance with the law and with the highest ethical standards. The Miyoshi Kasei Group workers must act honestly, fairly and with the highest standards of integrity and ethical business.



#### 3.1.1 Fair trade practices

The Miyoshi Kasei Group must be in compliance with all applicable fair trade laws of the countries and regions in which it operates, and conduct business with partners that are in compliance with such laws.

We exert due diligence in regards to business ethics, ensuring that our partners behave with the same business ethics as what we apply to ourselves.

The Miyoshi Kasei Group will neither provide nor accept gifts or entertainment that may cause suspicion regarding fairness or are in violation of the law.

We are engaged against corruption through awareness and training program for employees, and dedicated whistleblowing process to ensure that all suspicions of violations are investigated and corrected if the case may be.

## 3.1.2 Company reliability

The Miyoshi Kasei Group is committed to grow company's business and increase corporate value based on wise management practices, in order to provide long term vision to shareholders and other stakeholders.

We implement rules and practices to evaluate and guarantee the credibility and reliability of our financial and extra-financial reporting.

## 3.1.1 Information Security

The Miyoshi Kasei Group must handle its workers' personal information in the performance of their duties, in order to protect the privacy of those concerned, and must exercise the proper management control over it.

We place a great consideration to the protection of data that are collected, processed or stored by our Group for business purpose, including those of business partners, by implementing safe IT systems and companies' protection program.

#### 3.1.2 Intellectual property

The Miyoshi Kasei Group must manage and safeguard confidential and personal information and make best efforts not to infringe its suppliers' and customers' intellectual property.

We take necessary measures to avoid conflict of interest of any kind and require that each employee behaves responsibly according to our corporate rules.



The Miyoshi Kasei Group undertake efforts to acquire intellectual property rights and to maintain policies, procedures, and to conduct employee instruction and training concerning sensitive business information. It includes, but is not limited to: the prevention of infringement of intellectual property rights, identification and management of confidential business information, trade secrets, financial data, strategic plans... We do not use internal information regardless of its confidentiality status for any non-business related matter.

# 3.2 Sustainable purchasing

#### 3.2.1 Miyoshi CSR Act

In conducting transactions with others, the Miyoshi Kasei Group requires that they strictly fulfill the same commitment and engagement as we do.

We must collaborate with our suppliers in an effort to ensure that our raw materials meet our Quality standards, General terms and conditions, as well as CSR strategy. In addition to requiring suppliers to fully comply with our Miyoshi CSR Act, we also expect suppliers to ensure compliance among their own subcontractors involved in business related to us.

### 3.2.2 Suppliers assessment

The Miyoshi Kasei Group requires suppliers to answer to questionnaires, to accept on-site verification, and to submit materials and records, bearing the signature of an authorized representative of the company for the purpose of verifying that they are in compliance with our Miyoshi CSR Act. For that purpose, we assess our supplier regarding their CSR strategy and actions, enabling us to utilize the results of this evaluation as one of the key factors in selection of suppliers. If not fully aligned with the Act already, suppliers should be working towards compliance.

The Miyoshi Kasei Group shall obtain suppliers' agreement with the Miyoshi CSR Act prior to doing business, and shall request compliance with the Act's content and the submission of documentation that demonstrates suppliers' intention to comply with the it.

# 4 Treating the environment right

#### 4.1 General environmental ethic



The environment is at the heart of the Miyoshi Kasei Group CSR strategy. In addition to conduct business in full compliance with the environmental laws of the countries and regions of interest, we aim at reducing the impact of our activities on the planet.

We take actions to raise environmental awareness within our company and beyond in all our business activities and relationships, from the sourcing of our raw materials to the supply of our products and services.

#### 4.2 Climate

We are committed to cut our emissions from 50% by 2030 versus 2018 as a base year, following our engagement with SBTi (Scope 1&2). We commit to estimate our Scope 3-related emissions and build plan to progressively reduce them.

We shall implement all necessary actions to assess, reduce, mitigate or prevent our greenhouse gases emissions, arising from our comprehensive Bilan Carbone®\* calculation.

\*Bilan Carbone calculation consists of greenhouse gas accounting. It refers to processes used to measure how much carbon dioxide equivalents an organization emits.
